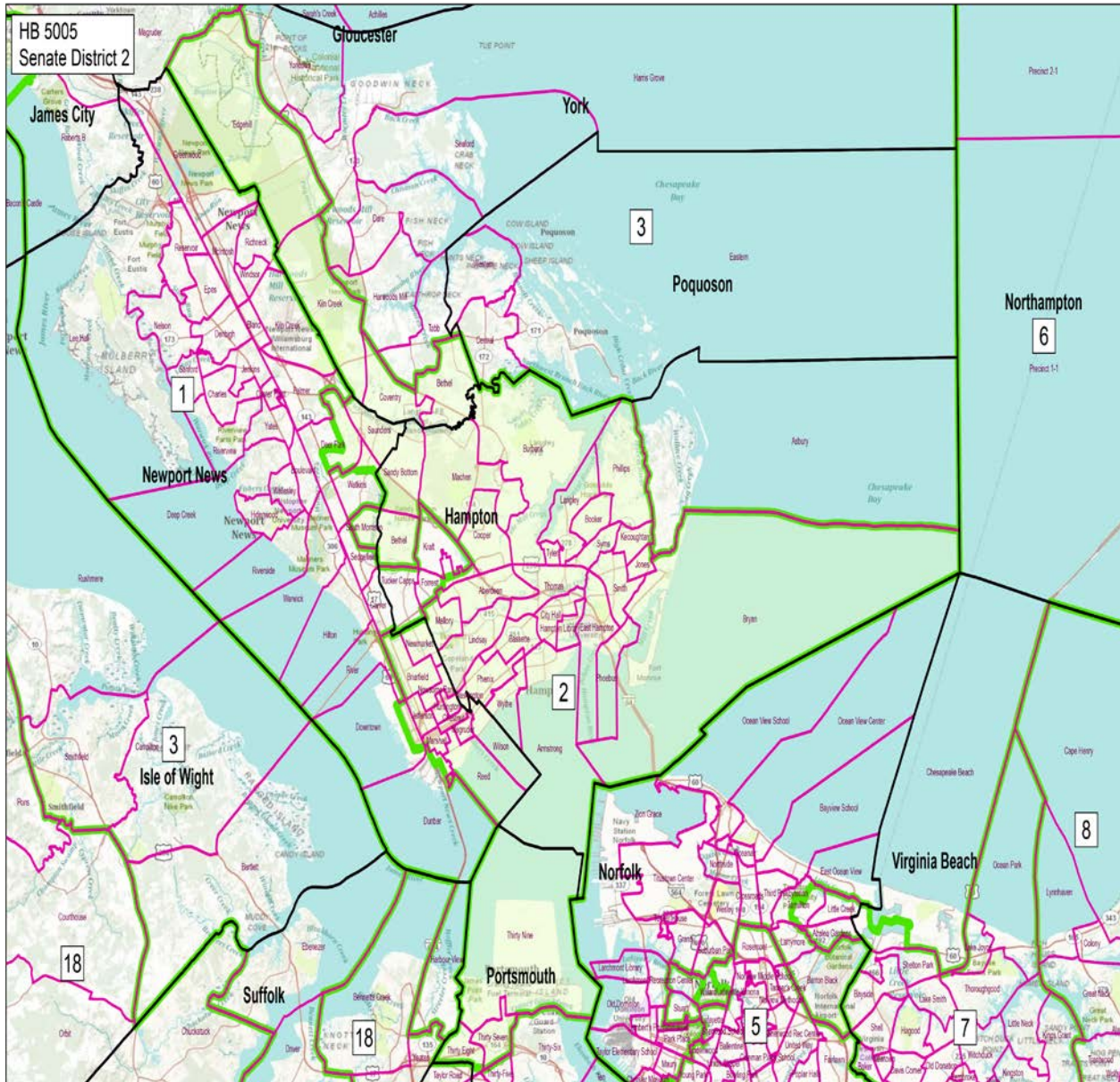

OTHER LEGISLATION

- MEALS TAX PARITY FOR COUNTIES (INTRODUCED ON BEHALF OF YORK COUNTY)
- ALLOWS A WOMAN TO WAIVE IN WRITING THE REQUIREMENT FOR MANDATORY TIME PERIOD OR PROVISION OF MATERIALS OR SPECIFIC INFORMATION FROM A PHYSICIAN PRIOR TO SEEKING AN ABORTION
- LOCAL OPTION BY ORDINANCE TO PROHIBIT THE SALE, DISTRIBUTION, OR SALE OF DISPOSABLE PLASTIC BAGS TO CONSUMERS
- CHANGES TO THE LANDLORD/TENANT LAW REGARDING NOTICE OF REQUIREMENTS; LANDLORDS ACCEPTING FULL OR PARTIAL RENT WHILE CONTINUING TO PROCEED WITH A COURT ACTION
